Sir/Madam,

I am directed to inform you that the Authority of the University of Burdwan has taken the following decisions related to admission to 2-yr. B.Ed. Programme (2020-22) in Self-financed B.Ed. colleges under this university:

1. As per Govt. order no. 520-Edn (CS)/10M-20/2015, dt. 16.09.2020, admission to B.Ed. Programme in Self-financed B.Ed. Colleges under B.U., will be done through **online mode only and under any circumstances, no student will be admitted directly by the Self-financed B.Ed. College Authorities, without recommendation of the university and the University Authority shall not be responsible for Registration and Enrolment of any student, if admitted directly by the College Authority, except on Management Quota Seats.**
2. Application fee for admission to B.Ed. Programme is Rs. 300/- + Bank's transaction charge, if any.
3. Eligibility : Candidates (both Fresh & Deputed) with at least 50% marks either in the Bachelor's Degree and/or in the Master's Degree in Science/Social Science/ Humanity/ Commerce, or Bachelor's in Engineering or Technology with specialization in Science and Mathematics with at least 55% marks, or any other qualification equivalent thereto, will be eligible for application. Relaxation of marks in favour of Reserved Category candidates shall be as per Govt. norms.
4. As per Govt. order no. 520-Edn (CS)/10M-20/2015, dt. 16.09.2020, ratio for home University students and other University students is 80:20.
5. No reservation of seats for OBC, SC & ST candidates will be applicable to Self-finance B.Ed. colleges.
6. SC/ST candidates of domicile state are entitled to get the marks relaxation facility i.e. SC/ ST candidates hailing from states other than West Bengal are not eligible for such benefits and they will be treated as General category candidates.
Candidates (both Fresh & Deputed), who are seeking marks relaxation against SC/ST category, must have to produce original caste certificate at the time of admission. The Certificate must be obtained from the competent authority to authenticate their claim. Relevant certificate must conform to THE W.B. GOVT. MEMO NO.1813-BCW/MR-94/11 dated Kolkata, 20th June, 2011. The certificate must be obtained from one of the authorities listed below:
 - i) Deputy Director, Backward Classes Welfare, West Bengal and Commissioner, Backward Classes Welfare, West Bengal in case of candidates claiming to be Scheduled Cast or Scheduled Tribe residing in any part of West Bengal.
 - ii) Deputy Commissioner of Land Revenue, Kolkata, Collector of Stamp Revenue, Kolkata, Metropolitan Magistrate, Kolkata, Addl. Chief Metropolitan Magistrate, Kolkata, Chief Metropolitan Magistrate, Kolkata, 1st Class Stipendiary Magistrate, Executive Magistrate, Sub-Divisional Magistrate, Sub-Divisional Officer, Deputy Collector, Addl. District Magistrate, Collector and District Magistrate with their respective jurisdictions in case of candidates claiming to be Scheduled Caste or Scheduled Tribe and ordinarily residing within such jurisdictions.

7. As per Govt. order no.1084 (20)-Edn (U)/EH/1U-89/13, dated, 07.12.2018, the percentage of reservation for the persons with disabilities shall be extended not less than 5% in each College. Candidates (both Fresh & Deputed), who are seeking reservation and relaxation in age and marks under DA category, must possess *relevant medical reports as well as the certificate* obtained from the competent authority to authenticate their claim and the certificate must be obtained from the authority not below the rank of a Superintendent of Sub-Divisional Hospital. In the certificate, the extent of Physical disability must not be less than 40%.
 8. Maximum age of fresh candidates will be 38 years as on 30th June, 2020 and there shall be relaxation of 5 years in case of DA category candidates.
 9. As per Govt. order no. 520-Edn (CS)/10M-20/2015, dt. 16.09.2020, in self-financing B.Ed. colleges, 10% seats will be reserved for untrained in service/ deputed teachers of classes V-XII. If the seats, reserved for deputed teachers remain vacant, may be de-reserved to make them available to freshers but not to Management Quota.
 10. Like previous years, the deputed candidates, having Honours/ P.G. in Santali/ Urdu/ Arabic /Work Edn. / Physical Edn./Agriculture/ Agronomy/ Home Science/ Home Management & Home Science will be eligible to B.Ed. programme under this University. However they will have to choose method subject from elective subjects which they have studied at the UG level and / or the PG level.
 11. Statistics, Computer Application, Computer Science, Engineering & Technology will be treated as the subjects in Mathematics and in this case candidates shall have to take Mathematics as the method subject.
 12. Bio-chemistry, Geology & Electronics will also be treated as subjects in the Physical Science and in this case candidates shall have to take Physical Science as the method.
 13. Bio-technology, Nutrition, Microbiology & Env.Sc. will also be treated as subjects in the Life Science and in this case candidates shall have to take Life Science as the method.
 14. Students of Sociology will be eligible to apply and in this case they shall have to take method subject from their elective subjects and accordingly they will be enlisted as per the method subject group to be mentioned by the applicants in the application forms.
 15. Like previous years' practice, the fresh candidates, having Honours/ P.G. in Santali/ Urdu/ Arabic will be eligible to B.Ed. programme under this University. However they will have to choose the method subjects from their Elective Subjects and accordingly they will be enlisted as per the method subject group to be mentioned by the applicants in the application forms.
 16. Availability of Method Subjects:
Bengali, English, Sanskrit, Hindi, Geography, History, Political Science, Philosophy, Education, Economics, Commerce, Music, Fine Arts., Life Science (Zoology, Botany, Physiology, Bio-technology, Nutrition, Micro-biology, Env.Sc.), Physical Science (Physics, Electronics, Chemistry, Bio-Chemistry, Geology), Mathematics (Statistics/ Computer Application /Computer Science / Engineering or Technology).
 17. In each Self-financed B.Ed. College 10% seats of total intake will be treated as the seats on Management Quota.
 18. Maximum course fee for pursuing this Programme in the academic session 2020-22 in Self-financed Colleges is Rs. 50,000/- maximum per annum per student. A student will pay not more than 20% of



annual course fee at the time of admission and the amount will be deposited directly to the college authority concerned . Details of Rs. 50,000/- will be as follows:

i) Tuition Fee	Rs.36000 (Maximum)
ii) Admission Fee	Rs. 3000 (Maximum)
iii) Development Fee	Rs. 5000 (Maximum)
iv) Library Fee	Rs. 2000 (Maximum)
v) Session Charge (Inclusive all other charges)	Rs. 4000 (Maximum)

Total Rs. 50,000

Note that total course fee for 2 years is maximum Rs. 1,00,000/-per student and no college authority will demand any amount in excess of the university prescribed fees.

[In addition to the above fees, students will pay only Registration fee, Enrollment fee, Examination fee, Centre fee etc. of the university separately]

19. The authority of each Self-financed College will spend Rs. 75,000/- only per unit (i.e. for 50 students) in every academic year for the benefit of the students in the form of relaxation of tuition fees. This benefit will be given to the poor and meritorious fresh candidates but not to the Candidates to be admitted on Management Quota.
20. At the time of submission of application form each applicant will be allowed to give maximum 15(fifteen) colleges as their choice subject to availability of seats and method subject.
21. Separate list for fresh and deputed applicants will be prepared as per the following groups :
 - i) Language Group (Bengali, English, Hindi, Sanskrit)
 - ii) Social Science Group (History, Geography, Pol. Science, Philosophy, Economics, Commerce, Education, Music, Fine Arts)
 - iii) Science Group (Zoology, Botany, Physiology, Bio-technology, Nutrition, Micro-biology, Env.Sc., Physics, Electronics, Chemistry, Bio-Chemistry, Geology)
 - iv) Mathematics Group (Math., Statistics, Computer Application, Computer Science, Engineering or Technology).
22. For Fresh Candidates, Provisional Rank list will be prepared on the basis of their total Grade Point to be computed as per the following norms:
 - i) 10% of the percentage of marks obtained at the M.P. (S.E.) or Equivalent Examination.
 - ii) 10% of the percentage of marks obtained at the H.S. (10+2) or Equivalent Examination.
 - iii) a) 15% of the percentage of marks obtained at the B.A./B.Sc./B.Com. (Gen.) Examinationor,
 - b) 20% of the percentage of marks obtained at the B.A./B.Sc./B.Com. Hons. or equivalent Examination
 - iv) 20% of the percentage of marks obtained at Post Graduate Examination.
 - v) a) 5 marks shall be awarded for M. Phil. Degree.
 - b) 8 marks shall be awarded for Ph. D. degree.
 - c) Candidates with M. Phil. & Ph. D. degrees both, only 8 marks will be awarded.

For Deputed Candidates, Provisional Rank list shall be prepared on the basis of their approved length of service as on 30.06.2020.



23. All testimonials are required to be uploaded online during application. Verification of documents will be done by the college at the time of admission maintaining COVID-19 Protocol. Admission will be cancelled if the documents are found not in conformity with the declaration in the forms submitted on-line.
24. All stakeholders shall adhere to the COVID-19 norms/protocol, issued by the Govt. from time to time.
25. As per UGC Guidelines, each student shall have to create his / her NAD Id and it is optional at the time of admission but mandatory before the registration of the admitted candidate. In case of any query in this regard please contact the NODAL OFFICER, NAD, BU (nad@buruniv.ac.in).
26. In case of cancellation of admission / migration of students, the entire fees shall be refunded by the college authority concerned after deduction of processing fee not more than 10% of the amount paid by the student at the time of admission. This process will remain valid during the entire period of admission only.
27. As per decision, taken by the Executive Council at its meeting held on 11.02.2021 vide item no. 313, in the session 2019-21, the self-financed B. Ed. Colleges under the University of Burdwan, who admitted students through off-line mode beyond Management quota violating the admission norms of the University, their approved intake will be reduced in the session 2020-2021 by 20% of the total number of students admitted through off-line mode beyond management quota and the calculation will be rounded-off. The decision of the council is applicable only to those colleges who admitted more than 2 students through off-line mode beyond management quota in the session 2019-21.
28. In regard to admission of students to this programme, the rules of The University of Burdwan, The Govt. of West Bengal & The NCTE shall strictly be followed by the colleges.
